Notes from the President

Hello Everyone!

Well, April has arrived along with the April showers! If it ever dries out, maybe we can get some riding in and start our spring projects. Our last meeting was our Awards meeting for trail mileage turned in for 2017. Those members who turned in their mileage reports were entered into a drawing for a Gift card. The winner was Holli Wheatley, congratulations Holli. I have attached the breakdown totals from our Trail Mileage Chair, Deb Sheka, later in the newsletter. Thanks Deb! There was cake to enjoy for not only the Awards but for two members with a birthday to celebrate! Happy Birthday to Paul Wilson and Mark Stevens. We also had a great attendance, with 25 folks! We welcomed some returning members, guest & secondary members from other chapters and new members. It was nice to see new faces. I hope everyone enjoyed themselves.

We had a busy meeting. I and several of our members attended the State OHC meeting on March 24th. I covered some of the topics covered at the meeting. Tom Green spoke and covered some info on the outreach work of the OHC, such as, working with the Ohio Trail Partnership (OTP) which is a group of trail users that consist of the Mt. Bikers, OHC, Buckeye Trail group, Rails to Trails and the Water Paddlers. All of these groups work together to help keep the trails in the Ohio Parks open. The OTP is highly supported by the ODNR, Wayne National Forest and the Division of Ohio Tourism. The OHC also affectively lobbies legislation for trails in Ohio. There are 30 Legislators of the Ohio Legislative Trail Caucus that support trails. The caucus is currently working on a resolution to make 2018 the "Year of the Trails" in Ohio. The ODNR now has a new person working for them that deals with the trails in the Ohio State Parks. His name is Tom Arbor and he is spoken very highly of by not only Tom but by Don

Wagner, our state Trail Chair. Mr. Arbor has met with all the groups of the OTP and collected information from all. He has created a website that should be on line in the coming weeks that deals with Ohio's trails and he has created an Advisory Committee to re-write the "State Trail Plan" and hopes to have it finished by the end of 2018. Tom also touched on the recent decision of the State Parks to permit regular campers to camp in the Horseman's Camps, as this has been a big concern for many. Director Obermiller of the ODNR said they can't designate a specific camping area for every user so the decision will stand. The parks will be placing signage in the Horse Camps with regards of the Ohio Equine Inherent Risk Law along with creating informative pamphlets to handout to those campers deciding to use the horse areas, explaining that they should not approach the horses, may experience flies, manure, etc., all the extra things that goes with being in close proximality to horses. Maybe this will deter some! They also had a guest speaker from the Creekside Horse Park located in Waynesburg Ohio. They will be hosting this year's IMTCA ride, (International Mountain Trail Challenge Association) in connection with the Ohio Quarter Horse All Breed Trail Ride. This event will be held June 14th thru the 17th. The 2017 Trail Mileage report was made by Ann Lindimore. The most used trails were given along with the top riders. Our Dillon State Park had 2790 miles reported! The rest of the break down should be on the State OHC Web page. There was a couple of by-law updates that was voted on also. The State Merchandise Committee has located a company to do our OHC merchandise. I have included the info sent out later in the newsletter with all the details. They had some of the clothing at the meeting and it looks really nice. There will also be some at the OHC booth at the Equine Affair to check out also. The Youth Group hosted the meeting this time and did a nice job.

Speaking of the Youth Group, as I reported in the last Newsletter, the LCOHC agreed to sponsor (5) youth again this year for the Youth Campouts this summer. We have three reserved so far. If you know any youth members that would like to attend any of the campouts, please get with me. The two remaining sponsorships will be donated to the Youth Group if we do not have any takers from our chapter. All the details & information, along with the applications are now on line on the State OHC Web page.

The Equine Affair is starting Thursday, April 12th. They are still looking for members to help out at the booth! If you are interested in helping out, please go on-line and sign-up or stop by the booth. The OHC will also be hosting two Educational Seminars, one on Thursday April 12th and Saturday April 14th. I'm not sure of the topics or the times, so be sure to check the schedule and try to attend one of them if you go.

The LCOHC Nominations Committee has been open since last year and it now has two members to take on the duties. Thank you to Chair, Bill Craft (bcraft51@gmail.com) and co-chair Sandy Belt (sandyb151@hotmail.com) for stepping up and volunteering. If you want to run for an Officers position for 2019 or know of someone who might like to do it, please contact Bill or Sandy. I know the President and the treasurer's positions will be open.

I was approached with an idea of a fund-raising opportunity by member, Mitzi Gerber. Announcements:

President Charlene reported on the **State Meeting** held on Saturday. She has a stack of a flyers from other counties for trail ride, shows, and auctions which is available for viewing. Tom Green (lawyer for the OHC and liaison with the state legislature) reported that the legislature is considering making 2018 "The Year of the Trails".

Tom Arbor from ODNR met with some groups. There will be a new web site and an advisory committee. The concern with the regular campers using the Horseman's Camp was discussed. The practice will continue but pamphlets will be made and distributed with recommendations and suggestions that it be the last resort. Additional signs (like the ones near stables) will be added.

Wayne National Forest is undergoing alterations to its fee structure. Until it is settled, there will not be a fee charged.
